Since its inception in 2007, Avell Studio has demonstrated unwavering dedication to Cesaga, persevering through funding challenges and periods of hiatus. Recognizing the immense potential of Cesaga's unique content and the transformative power of cryptocurrency, both our teams have aligned on a vision to expand this IP into novels, animation, games, music, and film, seamlessly integrating the SAGGA token to fuel this exciting transmedia journey.

## 2. Problem Statement

- **Launch Schedule:**
  - The token will be launched in within 7 to 10 days' time after the successful conclusion of the presale.
  - If the hard cap isn't reached within a year, the project team will adjust the roadmap and budget based on the amount collected and announce it on social media.

    - **Governance Participation:** Gain the ability to stake GG tokens to earn SAGGA Governance Tokens (SGG), granting voting rights on polls for comic filler and short animation development.

- Staking Rewards for GG Holders: Participants can stake their GG tokens to earn a passive reward of **1.5% of their staked amount in GG tokens per month, subject to the availability of tokens within the staking pool.**
- **Value Accrual through Buyback and Burn:** **7%** of the net profits generated from successful Cesaga projects will be strategically utilized for token buyback with the following breakdown:
  - **40% (of the 7%):** Burned to reduce the circulating supply.
  - **30% (of the 7%):** Added to the Liquidity Pool to enhance stability.
  - **20% (of the 7%):** Allocated to the Staking Pool to reward GG holders.

- \$28,000 USD worth of GG will be burned.
- \$21,000 USD worth of GG will be added to the Liquidity Pool.
- \$14,000 USD worth of GG will be allocated to the Staking Pool.
- \$7,000 USD worth of GG will be held in the Treasury.
- Access to Exclusive Cesaga Digital Collectibles and Experiences: GG token holders will gain access to exclusive digital content, including behind-the-scenes glimpses, early access to content drops, and unique Non-Fungible Tokens (NFTs) that offer further engagement within the Cesaga universe.
